Certified Erosion and Sediment Control Lead (CESCL) Training

Is your Certified Erosion and Sediment Control Lead (CESCL) designation about to expire? The Department of Ecology requires a CESCL on all stormwater permitted construction sites over an acre, and CESCL certifications must be renewed every three years with a one-day class.
